BETWEEN THE

STATE OF WASHINGTON DEPARTMENT OF ECOLOGY

AND

CITY OF REDMOND

PURPOSE: To amend the Agreement between the state of Washington Department of Ecology, hereinafter referred to as 'DEPARTMENT,' and the City of Redmond, hereinafter referred to as 'RECIPIENT,' for the Redmond Way Stormwater Treatment Facility project. This amendment is needed to change the project completion date, officially close out the project, and establish a final loan repayment schedule.

The RECIPIENT should review the original agreement conditions and requirements that apply during the loan repayment phase. For example:

- Attachment 4, Loan Repayment
- Attachment 4, Covenants and Agreements, Reserve Requirement

IT IS MUTUALLY AGREED that the LOAN agreement is amended as follows:

- 1) The original loan amount of \$4,412,000 remains unchanged.
- 2) The project completion date shall be June 30, 2015, and loan repayment shall commence no later than June 30, 2016.
- 3) The Estimated Loan Repayment Schedule Number 1750 created on February 21, 2012, shall be replaced with the attached Final Loan Repayment Schedule Number 2185 created on September 9, 2015.

All other terms and conditions of the original Agreement including any Amendments remain in full force and effect, except as expressly provided by this Amendment.

This Amendment is signed by persons who represent that they have the authority to execute this Amendment and bind their respective organizations to this Amendment.

This Amendment is effective upon the signature date of Ecology.
