AN ORDINANCE OF THE CITY COUNCIL OF THE CITY  
OF REDMOND, WASHINGTON, AMENDING  
SUPPLEMENTAL "S-PS" PAY PLAN IN ORDER TO SET  
SUPPLEMENTAL SALARIES FOR REDMOND POLICE  
ASSOCIATION REPRESENTING POLICE SUPPORT FOR  
THE YEAR 2010

---

WHEREAS, Resolution No. 1142 calls for an adjustment of salaries in keeping with changes in salaries in the local labor market of both private and municipal employers; and

WHEREAS, these changes should now be reflected by amending the supplemental S-PS pay plan for supplemental police support employees.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Pay Plan S-PS. Effective January 1, 2010, Supplemental Pay Plan S-PS, (formerly "C-1"), covering supplemental police support is hereby adjusted to reflect an 80 percent low to 110 percent high of the corresponding classifications lowest pay range as adopted by Ordinance No. 2512 for the RPA - police support bargaining unit. The amended Pay Plan is attached as Exhibit 1 and incorporated herein as if set forth in full.

Section 2. Severability. If any section, sentence, clause or phrase of this ordinance should be held to be invalid

or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.


Section 3. Effective Date. This ordinance shall take effect five days after its publication, or publication of a summary thereof, in the City's official newspaper.


