ORDINANCE NO. 2574

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY  
OF REDMOND, WASHINGTON, AMENDING THE 2011  
SUPPLEMENTAL "S-PS" PAY PLAN

---

WHEREAS, Resolution No. 1142 calls for an adjustment of salaries in keeping with changes in salaries in the local labor market of both private and municipal employers; and

WHEREAS, these changes should now be reflected by amending the supplemental S-PS pay plan for supplemental police support employees.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF REDMOND, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1.                    Pay Plan S-PS.            Effective March 1, 2011, Supplemental Pay Plan S-PS, (formerly "C-1"), covering supplemental police support is hereby adjusted to reflect pay ranges that represent 80 percent to 110 percent of the lowest pay for a comparable Regular Position as adopted by Ordinance No. 2572 for the RPA - police support bargaining unit. The amended Pay Plan is attached as Exhibit 1 and incorporated herein as if set forth in full.

Section 2.                    Severability.            If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not

affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3.                    Effective Date.    This ordinance shall take effect five days after its publication, or publication of a summary thereof, in the City's official newspaper.


